Pursuant to a previous Assessment Report, we revised the survey to shorten certain questions and to focus the survey on what the program chair believed to be the 50 most important student learning outcomes. Overall, in 87.5% of their responses students agreed or strongly agreed that they were capable of completing the tasks listed as student learning outcomes on their course syllabi. This is an improvement of 2.5% from the 2008 Student Satisfaction Survey. The Assessment Plan contemplates a student satisfaction rate of seventy percent. We have met and exceeded the Assessment Plan goal by 17.5%. As a result, we feel the Paralegal Program is doing a good job of meeting the Student Learning Outcomes listed in the program syllabi. The vast majority of students strongly agree or agree that they are capable of completing the tasks outlined by the Student Learning Outcomes.

Certain Student Learning Outcomes proved more difficult for the students. Eight students participated in the Spring 2010 Student Satisfaction Survey. Two students indicated they disagreed that they would have the ability to meet the Student Learning Outcomes described question number 10. One student disagreed or strongly disagreed that they would have the ability to meet the Student Learning Outcomes described in question numbers 3,4,7,9,11,13,19,27,37,41,42,43,47 and 49. [The questions are listed below and a detailed plan of improving student responses is included thereafter.]

The overwhelming majority of students gave positive responses to all questions regarding their knowledge and ability in the Wright College Paralegal Program main

courses (Civil Litigation; Family Law; Criminal Law; Tort Law; Real Estate Law; Business Law; Wills, Trusts and Probate; and Legal Research and Writing). Students also gave overwhelmingly positive responses to questions pertaining to General Legal Knowledge. Students seemed most concerned with their knowledge and abilities in Family Law and Legal Research and Writing. Although the majority of students did (generally 7 of 8 students) give positive responses to most questions in these subjects as well.
